ELiA offers a simply structured interface that is clearly structured according to individual forms and is supported by help, sample applications, default settings, key tables and plausibility checks. Saving is possible at any processing stage. The forms have to be processed in order, as there are dependencies between them.

Notes on shipping:

a) Postal dispatch on data carrier

You can send the application file with all attachments on CD, DVD or USB stick to the approval authority.

b) Electronic dispatch as a ZIP file via a secure mailbox (encrypted, possibly signed, automatic)
