You can have this permit extended if the permit period expires in the foreseeable future and the deposit has not yet been exhausted. To register, you will need a BundID and an identity card or residence permit with an active online ID function.</li> <li>• Call up the application form and fill it out completely and truthfully.</li> <li>• Upload the required documents as a file and send the application.</li> </ul> <p>Apply for an extension in writing:</p> <ul style="list-style-type: none"> <li>• Contact your responsible mining authority and coordinate the required application documents.</li> <li>• Submit the application and all required documents.</li> </ul> <p>Further procedural steps:</p> <ul style="list-style-type: none"> <li>• The competent authority will review your application and the documents submitted. Extensions are granted for a limited period of time that must be appropriate for the implementation of the planned extraction. This may only exceed 50 years if this is necessary in view of the investments normally required for extraction. If you interrupt your extraction work for longer than 3 years without good reason, the permit may be revoked.                                                                                                                                                                        |
