Volltext	If you are planning a cat or dog show, you must register it with the competent authority under certain conditions. The obligation to register is independent of whether dogs and cats participate together or only dogs or only cats.
Erforderliche Unterlagen	• Permit from the veterinary office • Event permit • Registration number from the veterinary office • For animals from EU countries or countries outside the EU: Animal health certificate Proof of vaccination Result of the blood test
Voraussetzungen	• You are organizing a dog and cat show. • You require a permit in the event of an exhibition. • You are holding the event in an area at risk of rabies or the animals come from EU member states or countries outside the EU (third country). • You are holding the event in an area where an animal disease to which dogs and cats are susceptible has occurred (information from the veterinary office).
Kosten	Depending on the measure and time required in accordance with the state ordinance on administrative fees in matters of veterinary administration of the state of Schleswig-Holstein.

- Upload all the necessary supporting documents for quick processing by the authorities.

- The responsible authority will contact you if there are any queries regarding the registration.
