Volltext	<p>Traffic signs and traffic facilities are used to regulate traffic. They are ordered by the authorities and must be observed by road users. Temporary orders for traffic signs and traffic facilities are also possible.</p> <p>However, traffic signs and devices may only be ordered if absolutely necessary.</p> <p>Traffic signs include</p> <ul style="list-style-type: none"> • Traffic signs, • road markings, • Traffic light displays (e.g. variable message signs). <p>Traffic facilities are</p> <ul style="list-style-type: none"> • Barriers, • barrier posts, • parking meters, • parking ticket machines, • railings, barriers, • guidance systems, • flashing light and traffic light systems ("traffic lights"). <p>All traffic signs are listed in the traffic sign catalog (VZKat).</p>
