Teaser	If you have German citizenship, you can apply for an identity card.
Volltext	As a person with German citizenship, you can have an identity card issued. If you have reached the age of 16 and do not have a valid passport, you must apply for an ID card. The period of validity of your ID card depends on your age at the time of application: • Application under the age of 24: ID card is valid for 6 years. • Application from the age of 24: ID card is valid for 10 years. Your ID card loses its validity before the expiry date entered on it if • Entries no longer apply or • your photo is no longer clearly suitable for identification purposes. This may be the case in particular with ID cards for infants or very young children. There is one exception: a change of address or height will not invalidate your ID card. You also have the option of applying for a temporary ID card. This is valid for a maximum of 3 months. You can submit the application to your identity card authority at your main place of residence, which is usually the Citizens' Registration Office. If there is an important reason, you can also apply for an ID card at an authority outside the jurisdiction of your place of residence. This may result in additional costs.

Erforderliche Unterlagen

- Proof of identity, for example old identity card, valid passport or children's passport
- current biometric photograph
- birth certificate, if applicable
- If applicable: certificate with current name, for example birth certificate, marriage certificate, marriage certificate, family register Declaration on the use of the name
- for children under the age of 16: Declaration of consent by the legal guardian if there is only one parent or legal guardian, additional proof of custody

Voraussetzungen

- You have German citizenship

For applications outside your main place of residence:

- You must be able to provide an important reason why you are not applying for the ID card at the ID card authority at your main place of residence.

Kosten

Gebühr: 30€

Surcharge on the fee for issuance by consular or diplomatic representation abroad. Fee reductions or exemptions are possible for people in need. This is at the discretion of the identity card authority.

Bearbeitungsdauer

2 - 3 Woche(n)

From the date of application until you can collect your ID card from the Citizens' Registration Office.

Frist

If the validity of your old ID card has expired and you are over 16 years old, you must apply for a new ID card immediately if you do not have a valid passport document.
