Volltext	If you want to organize a trade fair, exhibition or market, you will need what is known as an approval from the competent authority. You must apply for this in writing. Once you have been designated, you as the organizer may hold the trade fair, exhibition or market, but you are also obliged to hold the event. However, the event will only be authorized by the competent authority if the requirements of the trade regulations are met. Further requirements: • Personal reliability of the applicant, • fulfillment of the requirements set out in the trade regulations for the respective type of event, • suitable venue (for example, special markets may not take place in stores). As soon as the event has been approved, you will receive a written notification. The approval may be subject to conditions.
Erforderliche Unterlagen	• Completed application form or informal application with the following details: Name of the organizer, Date, time and place of the event, brief description of the event, details of the range of goods. • Certificate of good conduct of the organizer, • Extract from the central trade register, • expected list of participants, • occupancy plan of the planned rooms/spaces, • Conditions of participation, if applicable, • if applicable, proof of public market advertisement (text and place of publication of the advertisement carried out prior to the application). The authority may request further documents (e.g. a tax clearance certificate).

Kosten	The fee for fixing an event is € 232.00 (initial application) or € 70.00 (subsequent application).

Frist	An application deadline is not specified by law. However, it is advisable to apply in good time (up to six weeks before the start of the event).
