| Volltext                      | <p>Events within the meaning of the Industrial Code (GewO) are trade fairs, exhibitions, public festivals and markets (wholesale market, weekly market, funfair, special market).</p> <p>At the request of the organizer, the competent authority is obliged to determine the subject, time (period), location and opening hours of the event. With the determination, you as the organizer may hold the event, but are also obliged to hold it. Certain special regulations (so-called market privileges) are associated with the determination, such as changes to the provisions of the Shop Opening Act and the Public Holidays Act.</p> <p>In the public interest, for example if it serves to protect event participants from danger or public safety, the establishment or amendment of an establishment can be linked to conditions.</p> <p>In urgent cases, the competent authority may temporarily regulate the time, opening hours and/or location of the event in deviation from the regulations.</p> |
