|                                 | If you wish to vote in Germany, you must declare on oath that you are not voting in any other EU member state.  |
|                                 | Note: If you are unable to submit the application yourself, you can get help from other people. This may be necessary, for example, if you cannot read or are physically impaired. The person helping you must then also sign the application and the declaration in lieu of an oath. |

| Frist                           | You must submit the application by the 21st day before the election at the latest.  |

| Hinweise                        | If you move within Germany after submitting your application, the municipal administration of your old place of residence will decide on your application. It will inform the municipal administration of your new place of residence of its decision as soon as possible.            |
| Rechtsbehelf                    | You can inspect the electoral roll from 20th to 16th day before the election during the opening hours of your municipality.   |
