Erforderliche Unterlagen	<ul> <li>Your company number(s) under waste legislation as a collector, carrier, broker or. Dealer of waste (if already issued to you)</li> <li>the process number of your first notification (only if you wish to create a change notification)</li> <li>Your business registration (if you are required to register a business)</li> <li>an extract from the commercial, association or co-operative register (if an application has been made)</li> <li>Proof of business and environmental liability insurance (if such insurance exists)</li> <li>Proof of the expertise of the persons responsible for the performance and supervision of the business</li> <li>Proof of motor vehicle liability insurance (if you wish to apply for a collection or transport licence and the transport takes place on public roads)</li> </ul>
Voraussetzungen	The competent authority must grant the licence if • no facts are known that give rise to concerns about the reliability of the proprietor or the persons responsible for the management and supervision of the establishment, and • the proprietor, insofar as he is responsible for the performance of the establishment, the persons responsible for the management and supervision of the establishment and the other personnel have the necessary technical and professional expertise for their activities.

Verfahrensablauf	<ul> <li>You can submit your application by e-mail or using the online form.</li> <li>Enter your details and submit the required documents.</li> <li>In the case of the online form, you must provide a qualified electronic signature to finalise the application.</li> <li>For example, the signature card used in the electronic waste records procedure and the card reader used</li> </ul>

	<ul> <li>there can be used for this purpose. Signature software from Governikus, Signer WebEdition, is required for the signature. The software must be installed locally on your computer system in advance. You can find the download with instructions on the GOES website.</li> <li>The authority will send you a confirmation of receipt.</li> <li>After checking the application and your documents, the authority can request additional documents, grant the licence with or without ancillary provisions or reject the licence</li> </ul>
