	<p>for from the traffic authority.</p> <p>Tip: Larger events on public roads must be carefully planned and organised, for example with regard to safety or environmental protection measures. Depending on the event the requirements vary greatly depending on the type of event. You should therefore discuss the details with the responsible road traffic authority.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> • complete application, including necessary additional documents such as traffic sign plan, site plan, photos or sketches, which you must submit to the authorising authority on request • Proof of liability insurance cover • RSA qualification certificate in accordance with MVAS 99 RSA stands for guidelines for the road safety of road works. Every person who carries out road safety measures must be qualified in accordance with the MVAS 99 leaflet.
Voraussetzungen	<ul style="list-style-type: none"> • The organisation of the event on public roads is compatible with general traffic. • The routes are suitable. • You have taken adequate safety measures. • An organiser organises and runs the event responsibly. • There is adequate insurance cover. • Other relevant authorities have no objections.
Kosten	<p>depending on the fee schedule and the workload of the competent authority</p> <p>They take into account, among other things</p> <ul style="list-style-type: none"> • The nature and extent of the impact on the road • the economic interest of the applicant • The duration of the restriction of the road space <p>Information can be obtained from the competent authority.</p>
Verfahrensablauf	<p>Apply for the permit and the traffic law order from the competent authority. You can do this in person, in writing or digitally.</p>

	<p>The local road traffic authority will draw up the authorisation requirementssitions together with</p> <ul style="list-style-type: none"> • the person making the application, • the other authorities affected by the planned special use and the police • the police. <p>The competent authority will send you, as the applicant, the approved application in the form of a traffic order, possibly with conditions and requirements, as well as the permit in the form of a notice.</p>
Bearbeitungsdauer	Depending on the type, location and scope of the event: up to two months
Frist	Submit the application in good time, as the approval process can take up to 2 months for measures that require extensive coordination.
