Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Surname, first name of the person to be employed</li> <li>• Identification documents e.g. identity card / passport</li> </ul>
Voraussetzungen	<ul style="list-style-type: none"> <li>• Valid permit for the operation of a prostitution business</li> <li>• For processing, the person to be reported must agree to the background check</li> </ul>
Kosten	Registration is free of charge in Mecklenburg-Vorpommern.
Verfahrensablauf	<p>You submit the notification of other persons working in the prostitution trade to the competent authority.</p> <p>The competent authority carries out a background check.</p> <p>If the check is positive, you can employ the registered person in the prostitution trade.</p>
Bearbeitungsdauer	If the documents are complete, the application will be processed promptly.
Frist	Other persons working in the prostitution trade must be registered immediately.
