Beneficiaries Non-profit, legally responsible associations, federations and organizations with a registered office or at least a permanent branch in Mecklenburg-Vorpommern

Type and scope, amount of the grant The grants are awarded as non-repayable subsidies within the framework of project funding as proportional financing after coordination with other funding bodies in the amount of up to 80 percent of the eligible expenditure.

**Erforderliche Unterlagen**

- Project description
- Articles of association/partnership agreement
- Entry in the association/commercial register
- Certificate of exemption
- Personnel expenditure form
- Personnel suitability form
- Declaration on the prohibition of improper employment
- Declaration on the transparency database
- Rental agreement
- Leasing contract
- Confirmation of need from the local authority

The other documents required can be found on the application form.

Further documents may be requested by the approval authority to assess and review the project.

**Voraussetzungen**

Projects in Mecklenburg-Vorpommern are eligible for funding.

The need for the project should be confirmed by the administrative district or independent city on whose territory the project is being carried out.

For projects providing migration-specific advice and for language and vocational integration, staff must be qualified as

- social education workers or social pedagogues or
- social workers with state recognition or
- proof of an equivalent educational qualification
