Individual farm advisory projects in agriculture with the following content: 1. Advice on basic farm management requirements or standards for good agricultural and environmental condition, 2. Advice on agricultural practices that benefit the climate and the environment and the conservation of agricultural land, 3. Advice on measures and requirements in connection with climate change mitigation,

4. Advice on the conservation of biodiversity in agriculture and support for measures to implement it,
5. Advice on the conservation of genetic resources in agriculture,
6. Advice on the requirements or measures for water and soil protection,
7. Advice on requirements for particularly animal-friendly husbandry methods,
8. Advice on diversification, including that which serves sustainable regional development,
9. Advice on organic farming issues.

Who is supported?

The recipients of the advisory services are agricultural enterprises and producer associations. Funding is paid directly to the consultancy provider.

Project funding as partial funding in the form of a non-repayable grant of 60% to 100%
