Teaser	The disposal of waste paper from private households is the responsibility of the public waste disposal authorities. You can dispose of waste paper at the respective waste paper collection points and recycling centers.
Volltext	Recovered paper is a valuable raw material. Paper products made from waste paper (recycled paper, cardboard and cartons) have a significantly lower environmental impact than paper products made from virgin fibers. Recycled paper is therefore also awarded the Blue Angel eco-label. The disposal of paper waste from private households is the responsibility of the public waste disposal authorities. Waste paper collections can also be carried out by commercial or non-profit providers (commercial or non-profit collection).

Kosten	Information on the costs can be found in the respective waste fee statutes of your public waste disposal authority.
