Teaser	You can have your residence permit for the purpose of school-based vocational training extended before it expires if you wish to continue your school-based vocational training in Germany.
Volltext	The residence permit for the purpose of school-based vocational training is a temporary residence permit. You can apply to extend your residence permit if you wish to continue your vocational training beyond the period of validity of your residence permit. Apply for the extension of your residence permit at least eight weeks before the expiry date at the

	<ul> <li>immigration office responsible for your place of residence.</li> <li>The same conditions apply for the extension of a residence permit for the purpose of school-based vocational training as for the granting of a residence permit.</li> <li>If your residence permit is extended, it will be limited in time again. The residence permit for the purpose of school-based vocational training will be extended for the duration of the training.</li> <li>As a rule, the residence permit cannot be extended if this was already ruled out when the residence permit was issued or last extended.</li> </ul>

Voraussetzungen	<ul> <li>You have a recognized and valid passport or passport substitute and a valid residence permit for the purpose of school-based vocational training in accordance with Section 16a (2) of the Residence Act.</li> <li>Your residence permit will expire in the near future.</li> <li>There is no interest in deporting you.</li> <li>Your stay does not jeopardize or impair the interests of the Federal Republic of Germany.</li> <li>Your livelihood is secured for the duration of your vocational training.</li> <li>You have a training place in Germany that leads to a state-recognized vocational qualification in accordance with federal or state regulations.</li> </ul>
Kosten	<ul> <li>Extension of the residence permit for the purpose of school-based vocational training: for a further stay of up to three months: EUR 96.00 for a further stay of more than three months: EUR 93.00</li> <li>Under certain circumstances, a fee reduction or fee</li> </ul>

	The fee for reissuing the electronic residence permit (eAT card) is EUR 67.00.
Verfahrensablauf	The extension of your residence permit must be applied for at the foreigners authority responsible for your place of residence.
	<ul> <li>Depending on the foreigners authority and your request, it may be possible to apply online. Find out whether your foreigners authority offers electronic application for a residence permit.</li> <li>If the application can only be made in person, arrange an appointment with the immigration office.</li> <li>During the appointment, your application will be accepted and your supporting documents checked (please bring these with you to the appointment). Your fingerprints will be taken to issue the electronic residence permit (eAT).</li> <li>In the case of an electronic application, the Foreigners' Registration Office will contact you after receiving your online application to arrange an appointment at the Foreigners' Registration Office. During the appointment, your documents will be checked (please bring them with you to the appointment) and your fingerprints will be taken for the eAT card to be issued.</li> <li>If your application is approved, the Foreigners' Registration Office will arrange for the eAT card to be issued.</li> <li>After about six to eight weeks, you can collect your eAT card from the Foreigners' Registration Office.</li> </ul>

<ul> <li>Residence permit for the purpose of training; extension for the purpose of school-based vocational training</li> <li>A residence permit for the purpose of school-based vocational training can be extended if it is due to expire in the near future and the school-based vocational training is to be continued.</li> <li>The extension must be applied for at least eight weeks before the expiry date.</li> <li>An extension of the residence permit for the purpose of school-based vocational training is only possible if the requirements that were met when the permit was first issued are still met.</li> <li>In the case of an extension, the residence permit is again limited in time.</li> <li>An extension is not possible if this was already ruled out by the immigration authority when the permit was issued or when it was last extended.</li> <li>Depending on the foreigners authority and your request, you can apply online or in person.</li> <li>Fees are charged for the extension. The time and form of payment vary depending on the authority.</li> <li>Responsible: the foreigners authority responsible for the applicant's place of residence</li> </ul>
