Teaser	Under certain conditions, you can apply for a residence permit if there is a public interest in your employment, in particular a regional, economic or labor market policy interest. However, a formal qualification is not required.
Volltext	<p>You can apply for a residence permit for gainful employment if there is a public interest in your employment, in particular a regional, economic or labor market policy interest.</p> <p>The residence permit for employment in the public interest is a special right of residence that is only granted in justified individual cases. A public interest in employment can be justified, for example</p> <ul style="list-style-type: none"> <li>• if there is a regional or supra-regional public interest</li> </ul>

in the products or services of an employer or if there is a shortage of certain goods or services at the employer's location (regional interests). Supply or municipal policy reasons may also play a role here.

- if substantial investments and/or a significant number of jobs are created or secured; if the establishment of the company is associated with a sustainable improvement in the sales or market opportunities of domestic companies or if it involves the establishment of a production plant for technically high-quality (future-proof) and/or particularly environmentally friendly products (economic interests).
- if the employment maintains or creates jobs (labor market policy interests).

The private economic, operational interest of an employer alone is not sufficient to justify a public interest in employment.

You do not have to prove your qualifications. Recognition of their qualifications acquired abroad is also not required.

The Federal Employment Agency must give its approval before the residence permit is issued. The Federal Employment Agency also checks whether there is an interest in the labor market. Approval is granted for a maximum of four years.

If the residence permit is granted, it will be limited in time. Its validity depends on your employment contract or the period of validity of the Federal Employment Agency's approval.

Under certain circumstances, the immigration authority may require you to attend an integration course. This will then be noted on your residence permit.

If you are an employer and would like to hire an employee from abroad due to public interests, you can apply for the accelerated skilled worker procedure at the foreigners authority on behalf of the foreigner, which can facilitate and accelerate entry.

Under certain conditions, a fee reduction or fee exemption may be possible.

Note: The residence permit is issued as an electronic residence permit. The fee for reissuing the card body is EUR 67.00

## Verfahrensablauf

You must apply for a residence permit at the foreigners authority responsible for your place of residence. The procedure is as follows:

- Depending on the foreigners authority and your request, it may be possible to apply via the Internet. Find out whether your foreigners authority offers electronic applications for residence permits.
- If you can only apply in person, make an appointment with the immigration office. During the appointment, your application will be accepted and your supporting documents checked (bring these with you to the appointment). Your fingerprints will be taken for the production of an electronic residence permit (eAT card).
- In the case of an electronic application, the Immigration Office will contact you after receiving your online application to arrange an appointment at the Immigration Office if necessary. During the appointment, your documents will be checked (bring them with you to the appointment) and your fingerprints will be taken for the production of the electronic residence permit (eAT card).
- If your application is approved, the Foreigners' Registration Office will arrange for the eAT card to be issued.
- After about six to eight weeks, you can collect the eAT card from the immigration office.
- The eAT card must always be collected in person.
- Fees are charged for the issue of the residence permit. The time and form of payment vary depending on the authority.

- Residence permit for the purpose of gainful employment Issued for the purpose of employment in the public interest
- The residence permit is issued in justified individual cases if there is a public interest in the employment, in particular a regional, economic or labor market policy interest
- The employer's private or business interests are not decisive.
- No special qualifications are required.
- The Federal Employment Agency must approve the granting of the residence permit. The Federal Employment Agency examines in particular labor market policy interests.
- The residence permit is issued for a limited period. The period of validity depends on the employment contract or the approval of the Federal Employment Agency.
- Under certain circumstances, the immigration authority may oblige the applicant to take part in an integration course.
- Depending on the foreigners authority and the matter in question, applications can be made online or in person.
- A fee is charged for the issue of the residence permit.
