	You must take urgent care to apply for an extension or the issue of another residence permit (e.g. a permanent residence permit) before your residence permit expires.
	If the application is submitted in good time, i.e. before the expiry of the time limit, your continued residence is deemed to be permitted until the decision of the immigration authority with all subsequent effects (e.g. authorization to pursue gainful employment). A late
