The electoral roll is displayed at least at the location of the municipal administration. It can be inspected from the 20th to the 16th day before the election during general opening hours. It is only possible to inspect the data of other persons if you can provide credible evidence that the electoral roll is incorrect or incomplete. incompleteness of the electoral roll. In this context, you can produce extracts from the electoral roll in order to check the voting rights of specific individuals. The municipal authorities in Mecklenburg-Vorpommern are the municipal electoral authorities. The municipal electoral authorities are the district heads for the municipalities belonging to the district and the mayors for the other municipalities.

Kurztext	• Allow inspection of the electoral roll for the European elections • at least at the location of the municipal administration • to be made available on working days from the 20th to the 16th day before the election during general opening hours • Right of inspection initially only applies to own data • inspection of the data of other persons only if facts can be credibly demonstrated which may result in an inaccuracy or incompleteness of the voters' register • within this framework, persons entitled to vote may produce extracts from the electoral roll in connection with the verification of the voting rights of specific individuals • Responsible: Municipal authority
