Volltext	<p>Low-threshold offers for support in everyday life (care and relief offers) are offers according to § 45a para. 1 SGB XI, in which helpers under professional guidance</p> <ul style="list-style-type: none"> • take over the care of the beneficiaries in groups or individually in the home, • support the beneficiary in the home - especially with household chores, • accompany the beneficiaries in coping with general or care-related requirements of everyday life, • support the beneficiaries in organizing individually required assistance on their own responsibility, • relieve the burden on relatives or persons similarly close to them in their capacity as caregivers and provide them with advisory support. <p>If you want to offer a support service in everyday life, you need to be recognized by the state.
