Teaser	Is your company involved in the commercial transportation of goods or passengers and do you need a company card for the first time? Then you must apply for this card from the competent authority.
Volltext	You can apply for a company card as an entrepreneur or as an authorized representative or authorized person. You always need a company card if you use vehicles that must be equipped with a digital tachograph. As an entrepreneur, you are responsible for the proper use of the card or cards. You must also ensure that the company card is entered into the tachograph at the beginning and end of the vehicle's use for the company in order to assign the use of the vehicle to the company. You are also responsible for ensuring that the data read from the tachographs is saved regularly. You must hand these over to the authorities or their representatives on request. Company cards are valid for 5 years and are issued impersonally to the company. You can apply for several of these cards for your company. The number is limited to a maximum of 62

Erforderliche Unterlagen	• Application for a company card • documentary evidence of the name, address and registered office of the company • Proof of identity of the entrepreneur or the person or persons authorized to represent the company in accordance with the law, articles of association or partnership agreement
Voraussetzungen	Your company uses vehicles that must be equipped with a digital tachograph.
Kosten	Verwaltungsgebühr: 34€
Verfahrensablauf	Only complete and legible applications will be processed. Once the application documents have been received in full, the applicant will be notified of the costs. Once payment has been received, the LAGuS M-V will initiate the order for the company card from the Federal Motor Transport Authority (KBA). The card is then sent directly to the company by the KBA, usually within the following 5 working days.

- Company cards are valid for 5 years and are issued impersonally to the company
- Several cards can be requested for one company the number of company cards per company is limited to a maximum of 62 per card number series If additional company cards are required, a new application procedure must be started
- Responsible: different authorities depending on the federal state, e.g. driving license authority, TÜV, Dekra or others
