Teaser	If data in the electoral roll is incorrect, an application for correction can be submitted to the municipal electoral authority.
Volltext	The municipal electoral authority draws up a voters' register for each electoral district before each election. It contains the surname and first name, date of birth and home address of all eligible voters. All eligible voters who are registered with the registration authority on the 37th day before the election (key date) for a single residence or, in the case of multiple residences, for the main residence in the electoral district are entered in the voters' register ex officio. Every person entitled to vote has the right to check the accuracy or completeness of their personal data entered in the electoral roll during general opening hours on working days from the 20th to the 16th day before the election. Persons entitled to vote only have the right to inspect the electoral roll in order to check the data of other persons entered in the electoral roll if they can credibly demonstrate facts which may show that the electoral roll is incorrect or incomplete. The right to inspect the voters' register does not apply to the data of eligible voters for whom a blocking note has been entered in the register of residents pursuant to Section 51 (1) of the Federal Registration Act. Anyone who considers the voters' register to be incorrect or incomplete may submit an application for correction to the municipal electoral authority within

Frist	Within the inspection period (20th to 16th day before the election during general opening hours), an application for correction may be submitted to the municipal electoral authority.

Hinweise	If a person is wrongly not entered in a voters' register and it is no longer possible to add to it, they will receive a polling card on request.
