Teaser	If you have a valid partial building permit for the change of use of a facility for your building project, you can apply for an extension of up to one year at a time.
Volltext	If you have a valid partial building permit for your change of use, you can apply for an extension of the partial building permit. The responsible lower building supervisory authority can extend the partial building permit by a maximum of one year in each case if the legal requirements have not changed in the meantime. The extension of the partial building permit is subject to a fee.

	The cost calculation takes into account the expected costs of the construction work and the expenses for checking the legal requirements of the partial building permit.
Verfahrensablauf	Fill out the application and indicate which partial building permit your application for extension relates to. Submit the application to the responsible lower building supervisory authority. The lower building supervisory authority will examine your application and involve the municipality and those bodies whose involvement or consultation is required for the decision on the partial building permit or without whose opinion the application cannot be assessed. You will then receive the extension of the partial building permit. The extension of the partial building permit is subject to a fee. You will receive a notification of fees. If necessary, the lower building supervisory authority will ask you to make an advance fee payment as soon as you submit your application.
