Teaser	You can apply for an extension of the building permit for up to one year if you have a valid building permit for the construction of an installation for your building project.
Volltext	If you have a valid building permit for your construction project, you can apply for an extension of the building permit. The competent lower building supervisory authority can extend the building permit by a maximum of one year in each case if the legal requirements have not changed in the meantime and the application has been received by the competent building supervisory authority before the deadline expires.

Verfahrensablauf	Fill in the application form and state which building permit your application for extension relates to. The lower building supervisory authority will examine your application and involve the municipality and those bodies whose involvement or consultation is required for the decision on the building permit or without whose opinion the application cannot be assessed. You will then receive the extension of the building permit. The extension of the building permit is subject to a fee. You will receive a notification of fees. If necessary, the lower building supervisory authority will ask you to pay a fee in advance as soon as you submit your application.
