Teaser	If you have lost a weapon, ammunition or a weapons permit, such as a weapons possession card or a weapons license, you must report this immediately to the relevant weapons authority.
Volltext	You must immediately report the loss of weapons, ammunition and firearms licenses that require a permit. Weapons licensing documents include • Weapons possession card, • Ammunition purchase license, • firearms license, • small firearms license, • Shooting permit, • European firearms pass, • Replacement certificate for weapons possession card or weapons license, • other permit documents (e.g. weapons trading or manufacturing permit, carry or transfer permit, special permit for carrying weapons at public events). You can also indicate the loss of several weapons/ammunition and permit certificates in one report. If you report that you have lost permit documents, you should also apply for replacement documents to be issued to you at the same time. You must also report to the police that you have lost weapons and/or permit certificates.

	If you find the weapons and permits again, you must report this to the relevant weapons authority. You must return any replacement documents that have been issued.
Erforderliche Unterlagen	• Identity card or passport (copy)
Voraussetzungen	You have lost a weapon, ammunition or a permit.

Verfahrensablauf	You must report the loss of weapons, ammunition or permit certificates to the competent weapons authority.

Frist	You must report the loss immediately.

Hinweise	You can use the NWR identification numbers (NWR ID) to complete the form more quickly: • Your personal NWR ID (P or F NWR ID) for your personal details • the permit NWR ID for the firearms permit (E-NWR ID) • the weapon or weapon part NWR ID (W or T NWR ID). You can obtain the NWR IDs on request from the relevant weapons authority.

Kurztext	• Notification of the loss of weapons, ammunition or permit certificates requiring a permit • Loss of weapons, ammunition or permit certificates must be reported immediately to the responsible weapons authority • Notification of loss to the police is also required • Permission documents are gun ownership cards, hunting licenses, ammunition purchase licenses, gun licenses, small firearms licenses, shooting permits, European firearms pass, replacement certificate for gun ownership card (WBK), other permission documents (transfer permits, etc.).
