Teaser	Foreign nationals who have received a residence permit for employment as former tolerated persons can apply for an extension of their temporary residence permit.
Volltext	<p>You can apply for an extension of your residence permit for qualified tolerated persons issued for the purpose of employment if you wish to continue working and also continue to meet the other requirements. In principle, the same requirements must be met for the extension of the residence permit as for the initial issue. In particular, you must be able to cover your living expenses and health insurance from your own resources without claiming public benefits.</p> <p>In order to process your application, the Foreigners' Registration Office usually involves the Federal Employment Agency, which will check the working conditions. After holding the residence permit for two years and if you have been employed during this time in a job that corresponds to your professional qualifications, access to the labor market is no longer</p>

subject to any restrictions.

If your residence permit is extended, it will be limited in time again. As a rule, the residence permit cannot be extended if this was already ruled out when the residence permit was issued or last extended.

## Erforderliche Unterlagen

In principle, the extension of your residence permit requires the submission of the same documents as for the initial issue:

- recognized and valid identity document (e.g. passport or passport substitute)
- current biometric photo in passport format (45 x 35 mm)
- Proof of completed education (e.g. university degree, certificates of completed vocational training)
- For foreign university degrees: Notification of recognition or comparability of the university degree, if available Certificate evaluation from the Central Office for Foreign Education (ZAB), if available
- Employment contract or the "Declaration of employment" form completed and signed by the employer (see forms)
- Proof of previous employment (e.g. references, employment contracts), if available
- Proof of German language skills
- Proof of means of subsistence (e.g. equity capital, blocked account, declaration of commitment)
- Proof of health insurance cover
- Current registration certificate

In individual cases, the Immigration Office may require less or further proof.

## Voraussetzungen

In principle, you must meet the same requirements for the extension of the residence permit as for the initial issue of the residence permit, i.e:

- You have a recognized and valid identity document (for example, passport or passport substitute).
- You have in the federal territory completed qualified vocational training in a state-recognized or comparable regulated training occupation or a university degree or with a recognized university degree or a foreign

university degree comparable to a German university degree, have worked continuously for at least two years in an occupation that was appropriate to their degree or have been in qualified employment for at least three years without interruption and have not been dependent on public funds within the last year (with the exception of benefits to cover the necessary costs of accommodation and heating).

- You have sufficient German language skills at least at level B1 of the Common European Framework of Reference for Languages.
- You can present a concrete job offer or a contract (the form "Declaration of employment" serves as proof of the concrete job offer).
- You have sufficient living space for yourself and your family.
- The Federal Employment Agency has approved your employment.
- You can cover your living expenses and health insurance from your own resources without claiming public benefits.
- There are no grounds for deportation against you.

Your stay does not jeopardize or impair the interests of the Federal Republic of Germany

## Kosten

The following fees apply:

- 96.00 EUR for a further stay of up to three months
- 93.00 EUR for a further stay of more than three months

Remark:

Additional fees may apply for the issuance of a residence permit in the form of an electronic residence permit, which can also be used as electronic proof of identity.

## Verfahrensablauf

- Find out whether your foreigners authority allows you to apply online or has a special application form.
- If the application can only be submitted in person, make an appointment at the immigration office. If you apply online, the immigration office will contact you after receiving your application to arrange an

	<p>appointment.</p> <ul style="list-style-type: none"> <li>• During the appointment, your identity and documents will be checked (please bring your documents to the appointment, in the original if possible).</li> <li>• If your application is approved, your fingerprints will be taken to produce a new electronic residence permit (eAT card). The Foreigners' Registration Office will commission the Bundesdruckerei to produce the eAT card. After completion, you will receive information and can collect the residence permit from the relevant office. The eAT card must always be collected in person.</li> <li>• If your application is rejected, you will receive a notice of rejection.</li> </ul>
Bearbeitungsdauer	Duration: approx. 8 weeks Note for further information on the processing time: The production of the electronic residence permit by Bundesdruckerei takes about 4 to 6 weeks.
Frist	<p>Application deadline: The application should be received by the Immigration Office at least 8 weeks before your current residence permit expires.</p> <p>Objection period: 1 month</p>

- For the extension of the residence permit to formerly qualified tolerated persons for the purpose of employment, the foreign person must provide proof of sufficient living space.
- if the foreign national has held the residence permit for less than two years, they must still be seeking qualified employment or have a job offer for further employment corresponding to their professional qualifications
- if the foreign national has already been in possession of the residence permit for two years, the employment relationship must continue or a further job offer must be available (the residence permit entitles the holder to any employment after two years of employment corresponding to the professional qualification)
- The local immigration authority usually involves the Federal Employment Agency.
- The residence permit is generally extended for the duration of the employment, usually for two years.
- Responsible: the foreigners authority responsible for the applicant's place of residence
