from a state or state-recognized university or comparable educational institution in Germany or a previous residence permit as a researcher or scientist and its validity is about to expire, you can apply to extend your residence permit.

Make sure you submit your application in good time before your residence permit expires.

The residence permit will be issued again for up to three years.

## Erforderliche Unterlagen

In principle, the extension of your residence permit requires the submission of the same documents as for the initial issue:

- recognized and valid identity document (e.g. passport or passport substitute)
- current biometric photo in passport format (45 x 35 mm)
- Description of the self-employed activity (business plan)
- Proof of financing of the self-employed activity (e.g. proof of equity capital, financing commitment from a bank).
- Extract from the commercial register or business registration
- Proof of livelihood (e.g. proof of income, equity capital, blocked account, declaration of commitment)
- Proof of health insurance cover (e.g. confirmation of health insurance cover or insurance policy).
- After the age of 45: Proof of adequate pension provision (e.g. proof of own assets, acquired pension entitlements, business assets)

The documents and information must always be submitted in German. In individual cases, the foreigners authority may require less or further proof.

If necessary, you may also have to submit proof of your degree from a state-recognized university or comparable educational institution in Germany or your old employment contract as a scientist and researcher to the immigration authority again in order to prove the connection between your previous employment

Voraussetzungen	<p>In principle, the same requirements must be met for the extension of the residence permit as for the initial issue of the residence permit. This means that</p> <ul style="list-style-type: none"> <li>• The period of validity of your current residence permit will expire in the near future.</li> <li>• You wish to continue your self-employed or freelance activity in Germany.</li> <li>• Your self-employed activity is still related to the knowledge you acquired during your university education or during your previous work as a researcher or scientist.</li> <li>• You can continue to secure your livelihood and health insurance cover without claiming public benefits.</li> <li>• If you have reached the age of 45, you can prove that you have adequate pension provision (does not apply to persons with Turkish citizenship).</li> <li>• There are no grounds for deportation against you.</li> </ul>
Kosten	<ul style="list-style-type: none"> <li>• 96.00 EUR for a further stay of up to three months</li> <li>• 93.00 EUR for a further stay of more than three months</li> </ul> <p>Remark: The residence permit in the form of the electronic residence permit (eAT card), which can also be used as electronic proof of identity, must be reissued for the extension. This may incur additional fees.</p> <p>The time and form of fee collection and payment vary depending on the authority.</p> <p>In certain cases, fee reductions or exemptions may apply (e.g. for persons entitled to asylum or recognized refugees). Lower fees may apply for Turkish nationals.</p>
Verfahrensablauf	<ul style="list-style-type: none"> <li>• Find out whether your foreigners authority allows you to apply online or has a special application form.</li> <li>• If the application can only be submitted in person, make an appointment at the immigration office. If you apply online, the immigration office will contact you after receiving your application to arrange an appointment.</li> </ul>

- During the appointment, your identity and documents will be checked (please bring your original documents with you to the appointment if possible).
- If your application is approved, your fingerprints will be taken in order to produce the residence permit in the form of a new electronic residence permit (eAT card).
- The Foreigners' Registration Office will commission the Bundesdruckerei to produce the eAT card. After completion, you will receive information and can collect the eAT card from the relevant office. The eAT card must always be collected in person.
- If your application is rejected, you will receive a notice of rejection.

**Bearbeitungsdauer**

6 weeks to 8 weeks. The processing time may vary depending on how busy the immigration office is. The production of the electronic residence permit by the Bundesdruckerei takes around 4 to 6 weeks.

**Frist**

Application period: 6 weeks to 8 weeks. The extension of the residence permit must be applied for before the validity of the current residence permit expires. The application should be received by the Foreigners' Registration Office at least six to eight weeks before the residence permit expires. Period of validity: maximum 3 years. The residence permit can be issued for up to three years.

**Hinweise**

- Self-employment is any self-employed, permitted activity that is intended to generate a profit and is of a certain duration, provided it is not an employment relationship.
- The extension of the residence permit is at the discretion of the responsible immigration authority. Applicants are therefore only entitled to a decision free of discretionary errors.

## Sachverhalt

- After three years of holding a residence permit for self-employment, you can apply for a permanent residence permit (settlement permit) under simplified conditions (see service "Issuing a settlement permit for self-employment").
- For freelancers, other conditions apply for the extension of the residence permit and for obtaining a settlement permit.
- The procedure is usually carried out in German.
- All information provided to the Foreigners' Registration Office should be correct and complete to the best of your knowledge and belief so that your application can be processed without major delays.
- Incorrect or incomplete information can slow down the procedure and be detrimental to the person concerned. In serious cases, incorrect or incomplete information that is not completed or corrected in good time vis-à-vis the immigration authority can result in the revocation of residence rights that have already been granted, a fine, a prison sentence of up to three years or expulsion from the federal territory.
- Due to the complexity of residence law, this description is for information purposes only and is not legally binding.

## Rechtsbehelf

- Appeal against the decision of the immigration authority within one month of notification.
- Legal action before the court named in the objection notice if the objection is not upheld

- Residence permit for the purpose of gainful employment; extension for self-employed former scientists and researchers
- The extension of a residence permit for the purpose of self-employment is possible if the current residence permit was issued on the basis of Section 21 (2a) AufenthG and is still valid.
- In principle, the same requirements must be met for the extension of the residence permit as for the initial issue of the residence permit.
- The self-employed activity must continue to show a connection with the knowledge acquired during higher education or the previous activity as a researcher or scientist.
- Living expenses (including health insurance) must be
