Teaser	Are you applying for a permit for installations under the simplified procedure? Then you can obtain a permit from the competent authority for the construction and operation of installations of a certain type or scope without public participation.

Modul	Sachverhalt
Volltext	Permits for installations of a certain type or scope can be issued in a simplified procedure. In these cases, the procedure is carried out without public participation. You will receive a permit if you fulfill the obligations under the Federal Immission Control Act and the project does not conflict with any other public law regulations. The cases in which a simplified approval procedure is possible can be found in the legal basis.
Erforderliche Unterlagen	• main application • Required drawings, plans or expert opinions • Explanatory notes on the installation • Other documents (if necessary, ask the competent authority)
Voraussetzungen	• You must prove that you will comply with the obligations of the Federal Immission Control Act when constructing and operating a plant. • No other public law regulations or occupational health and safety concerns stand in the way of the project.
Kosten	Fees are charged for the official act. The amount is primarily based on the installation costs of the facility or the administrative costs. Further details are regulated by the Immission Control Costs Ordinance M-V.
Verfahrensablauf	If you wish to apply to the competent authority for the construction and operation of an installation requiring a permit under immission control legislation using the simplified procedure, you must first submit the application documents in full. You can do this in writing or electronically. The competent authority will confirm receipt of the application in writing or electronically, check it for completeness and, if necessary, involve other specialist authorities. If necessary, the authority will request further documents.
