A significant change is any:

- modification which, according to the assessment of the competent authority, may have a significant negative impact on human health or the environment
- A change in nominal capacity which, in the case of installations of numbers 1.1, 1.3, 9.2 or 11.1 of Annex I with a solvent consumption of 25 t/a or less, points 4.1 to 4.5, 8.1, 9.1, 10.1, 10.2, 12.1 or 14.1 of Annex I with a solvent consumption of 15 t/a or less, points 2.1, 5.1, 7.2, 13.1 or 15.1 of Annex I with a solvent consumption of 10 t/a or less, numbers 16.1 to 16.4 of Annex I with a solvent consumption of 500 t/a or less

leads to an increase in emissions of volatile organic compounds of more than 25 percent.

Change in rated capacity that leads to an increase in emissions of volatile organic compounds of more than 10 percent.

**Erforderliche Unterlagen**

Complete display with the relevant data for the system.

**Voraussetzungen**

You are planning a significant change to a system operated by you with a solvent consumption above the threshold values according to Annex I of the 31st BImSchV.

**Kosten**

Verwaltungsgebühr: 100€ - 2.250€  
 Fees are charged for the official act. The amount is primarily based on the installation costs of the facility or the administrative costs. Further details are regulated by the Immission Control Costs Ordinance M-V.

**Verfahrensablauf**

- You submit your notification with the relevant data for the installation to the authority responsible for you.
- The competent authority checks your notification.
- If necessary, the competent authority will request further documents from you.

**Bearbeitungsdauer**

There is no processing deadline.
