These include, among others:

- Watchmakers,
- Goldsmiths and silversmiths,
- wood carvers,
- sailmakers,
- shoemakers,
- millers,
- brewers and maltsters,
- textile cleaners,
- building cleaners,
- photographers,
- bookbinders and
- violin makers.

Trades similar to crafts are listed in Section 2 of Annex B of the Crafts Code. These include, among others:

- Ironworkers,
- floor layers,
- metal grinders and metal polishers,
- vehicle recyclers,
- pipe and sewer cleaners,
- ice cream makers,
- beauticians and
- piano tuners.

In order for the register to be kept correctly, there is a legal obligation to notify the Chamber of Skilled Crafts of the commencement or termination of self-employment in a craft or similar trade that does not require a license. Notification of the start of operations triggers a procedure for entry in the register.

Erforderliche Unterlagen

The actual notification of the start of operation of a craft that does not require a license or a craft-like trade can be made informally. The following documents must be submitted for the subsequent registration procedure:

- Copy of identity card or comparable identification document
- Copy of the business registration (can be submitted later)

Companies under civil law (GbR):

- Copies of the identity cards or comparable identification documents of the partners or persons authorized to represent the company
- Copy of the articles of association (if not concluded informally)
- Copy of the business registration (can be submitted later)

Commercial partnerships with legal capacity, general partnerships (OHG), limited partnerships (KG) and corresponding foreign company forms:

- Copies of the identity cards or comparable identification documents of the partners or persons authorized to represent the company
- for proof of the legal form of the company if the company is based in Germany: for companies entered in the commercial register: extract from the register, for general partnerships additionally a copy of the articles of association if no entry in the register has been made: copy of the articles of association for foreign legal forms: Extract from the relevant foreign register for companies entered in registers, otherwise - copy of the articles of association
- Copy of the business registration (can be submitted later)

Legal entities - limited liability company (GmbH), limited liability entrepreneurial company (UG), public limited company (AG), registered cooperative (eG):

- Copies of the identity cards or comparable identification documents of the persons authorized to represent the company
- for proof of the company's legal form: for companies based in Germany: extract from the commercial or cooperative register for foreign legal forms: Extract from the relevant foreign register

- Entry in the register of proprietors of a craft not requiring a license or a trade similar to a craft is possible for natural or legal persons and partnerships with legal capacity
- No proof of qualification is required for entry in the register
- Master craftsman titles for trades not requiring a license can be acquired voluntarily
- Responsible: Chamber of Crafts in whose district the commercial establishment is located
