Volltext	If you wish to conduct an auction, you must the responsible authorities at least two weeks before the planned auction date. at the latest.  The notification must be submitted to the competent authorityin whose district the auction is to take place and secondly to the Chamber of Industry and Commerce, in whose district the auction is to take place,  Exceptionally you can request a shortening of the deadline or the authorization of an exception request:  Reduction of the notification period of at least two weeks before the auction date, in particular in the case of perishable auctioned goods  Exemption from the obligation to have the auctioned property inspected for at least two hours (if you you have given the bidders bidders sufficient opportunity to assess the auctioned item in another way)
