Volltext	<p>Due to their nature or operation, installations can cause harmful environmental effects or otherwise endanger, significantly disadvantage or significantly inconvenience the general public or the neighborhood.</p> <p>If you want to set up and operate such a facility, you need a permit from the competent authority.</p> <p>Stationary waste disposal facilities for the storage or treatment of waste are also subject to approval.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> • Application form • Description of the project, including details of plant components, process steps, material and product data • schematic representation, flow diagrams • Information on possible disruptions to intended operation • Information on safety and protective measures (e.g. emission reduction measures, planned measurements, occupational safety measures, noise protection measures) • Information on emissions and immissions (forecast), e.g. of air pollutants, noise • Information on waste and waste water • Building documents: Site plan, construction drawings, building description (form), description of site drainage, possibly structural engineering certificates (for structural engineering inspection)
Voraussetzungen	<ul style="list-style-type: none"> • The installation must not have any harmful effects on the environment or other hazards, significant disadvantages or significant nuisances for the general public or the neighborhood. • Unavoidable harmful environmental effects of the plant must be kept to a minimum in accordance with the state of the art. • The waste generated during the operation of the plant must be disposed of properly. • Energy must be used sparingly and efficiently. • Other public law regulations and occupational health and safety concerns must not conflict with the project.
Kosten	Fees are charged for the official act. The amount is primarily based on the installation costs of the facility or the administrative costs. Further details are
