Teaser	If you want to rent an apartment whose construction was subsidized with public funds, you need a certificate of eligibility for housing.
Volltext	A certificate of eligibility for housing is required if someone wants to rent an apartment whose construction was subsidized with public funds. The certificate of eligibility for housing is a certificate that can be issued to the applicant against proof of income, which must not exceed a certain amount. The certificate of eligibility for housing is issued on application upon presentation of proof of the income of the person seeking housing and the members of their household.
Erforderliche Unterlagen	Proof of the total annual income of the household members
Voraussetzungen	Eligible applicants are those seeking accommodation

	who are not only staying temporarily in the area covered by this law and who are in a position to establish a long-term residence as the center of their life and to run an independent household. The receipt of a residence entitlement certificate is dependent on income. Therefore, only households whose total income does not exceed the income limit are granted a certificate of eligibility for housing.

Kurztext	A housing entitlement certificate is a certificate that can be issued to the applicant against proof of income, which may not exceed a certain amount, and entitles him or her to rent an apartment whose construction was subsidized with public funds.
