Volltext	The competent authority must be notified of the commencement or cessation of operations for the commercial manufacture and/or trade of weapons. Failure to do so constitutes a misdemeanor pursuant to Section 53 (1) (8) of the Weapons Act.
Erforderliche Unterlagen	• Weapons manufacturing license or weapons trade license
Voraussetzungen	The firearms manufacturing license or firearms trade license must have been issued.
Kosten	The weapons authority charges a fee in accordance with No. 1.1 of the Annex to the Thuringian General Administrative Costs Regulations.
Verfahrensablauf	The notification must be made by the holder of the firearms manufacturing license or firearms trading license to the firearms authority responsible for the place of operation.

Frist	The notification must be made within two weeks of the commencement or cessation of operations.

Hinweise	Any person who fails to make the notification, or fails to make it correctly, completely, in the prescribed manner or in good time, shall be deemed to have committed an administrative offense. The administrative offense may be punished by a fine of up to ten thousand euros (§ 53 paragraph 1 No. 8 in conjunction with. Paragraph 2 WaffG).
