The desired gainful employment can also be self-employment.</p> <p>This residence permit can be issued for up to 18 months. The residence permit only serves the one-time purpose of seeking employment and cannot be</p>

The time and the form of the fee collection as well as the payment vary depending on the authority.

Verfahrensablauf

- Find out whether your foreigners authority allows you to apply online or has a special application form.
- If the application can only be submitted in person, make an appointment at the Aliens' Registration Office. In the case of online application, the Aliens' Registration Office will contact you after receiving your application to schedule an appointment.
- During the appointment, your identity and documents will be checked (please bring your documents to the appointment, if possible in original).
- If your application is granted, your fingerprints will be taken for the production of a new electronic residence permit (eAT card). The Aliens' Registration Office will order the production of the eAT card from the Bundesdruckerei. After completion, you will receive information and can pick up the residence permit at the responsible office. The eAT card must always be collected in person.
- If your application is rejected, you will receive a rejection notice.

Bearbeitungsdauer

It takes about 4 to 6 weeks for the Bundesdruckerei to produce the electronic residence permit.

Frist

- The residence permit should be applied for at least eight weeks before your visa or current residence permit expires.
- The residence permit is issued for a maximum of 18 months.
- Time limit for action: one month

Kurztext	<ul style="list-style-type: none"> • Residence Permit for the Purpose of Gainful Employment Issuance for Job Search after Completion of Studies • Foreign graduates of German universities can obtain a residence permit for the purpose of seeking employment after completing their studies • Prior possession of a residence permit for the purpose of studying (§ 16b or § 16c Residence Act) is required. • The employment sought must be related to the qualification acquired during studies. The establishment of self-employment is also possible. • Residence permits are issued for up to 18 months and cannot be extended. • Any gainful employment is permitted during the job search. • Responsible: the foreigners authority responsible for the applicant's place of residence.
