Teaser	If you are a civil servant working for a German employer, you can obtain a residence permit to fulfill your official duties in Germany.
Volltext	<p>If you are employed as a civil servant by a German employer, you are entitled to a residence permit to fulfill your official duties in Germany.</p> <p>In particular, university teachers and other members of the academic and artistic staff who have been appointed as civil servants may be granted a residence permit.</p> <p>The residence permit is issued for a period of three years, unless a shorter period is planned for your stay in Germany.</p> <p>The involvement of the Federal Employment Agency is not required for the issuance of the residence permit.</p> <p>Under certain circumstances, you may be required by the Aliens' Registration Office to attend an integration course. This will then be noted on your residence permit.</p> <p>With the receipt of a residence permit for the performance of official duties with a German employer, you have the possibility of receiving an unlimited right of residence (settlement permit) after</p>

only three years. The requirement to have paid contributions to the statutory pension insurance for at least 60 months is waived.

German employers who wish to bring a foreign civil servant from abroad to Germany to fulfill official duties can apply to the Foreigners' Registration Office for the accelerated specialist procedure, with which entry can be facilitated and expedited, on behalf of the foreigner.

Union citizens who are in a civil servant relationship with a German employer are not subject to the Residence Act, but to the Freedom of Movement Act/EU.

## Erforderliche Unterlagen

- Valid passport or passport replacement
- Original of your appointment/appointment certificate
- Current biometric photo
- Proof of your health insurance
- Rental agreement
- In addition, if you recently entered the country: Visa, if this was required for entry.
- As well as in case of a previous stay: Acute residence permit

For the implementation of the accelerated skilled worker procedure, further documents are required. Please contact the relevant foreigners authority for this.

## Voraussetzungen

- You have a recognized and valid passport or passport replacement and - if required for entry - an appropriate visa.
- There is no interest in deportation against you.
- Your stay does not endanger or impair the interests of the Federal Republic of Germany.
- You are in a civil servant relationship with a German employer and are to fulfill official duties in Germany.

Under certain conditions, a fee reduction or fee exemption may be considered.

## Verfahrensablauf

The residence permit must be applied for at the aliens' registration office responsible for your place of residence. The procedure is as follows:

- Depending on the foreigners authority and your concerns, it may be possible to apply via the Internet. Find out whether your foreigners authority offers electronic application for the residence permit. In the case of an electronic application, the Aliens' Registration Office will contact you after receiving your application to arrange an appointment at the Aliens' Registration Office. During the appointment, your supporting documents will be reviewed (bring them with you to the appointment).
- If the application can only be submitted in person, make an appointment with the Aliens' Registration Office. During the appointment, your application will be received and your supporting documents will be checked (bring them with you to the appointment).
- For the renewal of the electronic residence permit (eAT card), your fingerprints will be taken at the Aliens' Registration Office.
- After about six to eight weeks, you can pick up your eAT card at the Aliens' Registration Office. As a rule, you must pick it up in person.
- There are fees for the issuance of the residence permit. The timing as well as the form of payment varies depending on the authority.

To carry out the accelerated skilled worker procedure, the German employer contacts the foreigners authority responsible for the place of employment. Under certain circumstances, a central office has been set up in the federal state to carry out the procedure.

## Frist

- The residence permit should be applied for at least eight weeks before the expiry of your still valid visa or residence permit.
- The residence permit is issued for a period of three years if the service in the Federal

An appeal against the decision of the Foreigners' Registration Office may be filed with the court specified in the decision.

**Kurztext**

- Residence permit for the purpose of gainful employment Issued for employment as a civil servant with a German employer
- Residence permit is issued to foreigners who are in a civil servant relationship with a German employer for the purpose of fulfilling official duties in the Federal territory.
- No approval of the Federal Employment Agency required.
- Residence permit is issued for a period of three years if the employment relationship is not limited to a shorter period.
- Under certain circumstances, the foreigners authority may require the applicant to attend an integration course.
- Holders of a residence permit as a civil servant to fulfill official duties in Germany can obtain a settlement permit after three years under simplified conditions.
- Depending on the foreigners authority and the issue, the application can be made via the Internet or in person.
- A fee is charged for the issuance of the residence permit. The timing as well as the form of payment varies depending on the authority.
- German employers can apply to the Foreigners Authority for the accelerated procedure for skilled workers if they wish to bring a foreign skilled worker in a German civil service relationship from abroad to Germany to fulfill official duties.
- Responsible: the foreigners authority responsible for the applicant's place of residence; for the accelerated skilled worker procedure: The foreigners authority at the place of employment where the foreigner is to be deployed, unless a central office has been set up for
