| Teaser | As a researcher, you have a legal entitlement to a work permit to look for a job for a maximum of 9 months directly following your research activity. |
| Volltext | As a researcher, you have a legal entitlement to a residence permit to look for a job. The residence permit will be issued to you for a maximum of 9 months directly following your research activities. If this maximum period was not used up when the permit was first issued, the residence permit can be extended accordingly. The aim of the search can also be self-employment. However, if you do not find a job during these 9 months, an extension is excluded and you are obliged to leave the federal territory. This residence permit allows you to work without restriction. |

checked (please bring these with you to the appointment). For the issue of the electronic residence permit (eAT card), your fingerprints will be taken.

- In the case of an electronic application, the Foreigners' Registration Office will contact you after receiving your online application to arrange an appointment at the Foreigners' Registration Office. During the appointment, your documents will be checked (please bring them with you to the appointment) and your fingerprints will be taken for the issue of the eAT card.
- If your application is approved, the Foreigners' Registration Office will arrange for the eAT card.
- After about six to eight weeks you can eAT card from the Foreigners' Registration Office.

Fees are charged for the extension of the residence permit. The time and form of payment vary depending on the authority.

- Extension of the residence permit: at the latest eight weeks before your valid residence permit expires.
- The residence permit is limited to 9 months, including any extension.
- Deadline for appeal: 1 month
