Teaser	If you submit an application under the simplified procedure for the approval of installations, you can obtain a permit for the construction and/or operation for installations of a certain type or scope without public participation from the competent authority.
Volltext	The approval of installations of a certain type or size can be granted to you in a simplified procedure by the competent authority. The approval procedure takes place without public participation.
Erforderliche Unterlagen	Specific information on the required documents is not possible due to the large number. Information on this can be obtained from the responsible office.
Voraussetzungen	The prerequisite is that this is compatible with the protection of the general public and the neighborhood in terms of the type, extent and duration of the harmful effects on the environment and other hazards, significant disadvantages and significant nuisances caused by these installations. A permit in accordance with § 19 Federal Immission Control Act cannot be issued to you if problems arise with the appropriate safety distance when approving operating areas. It is essential that you contact your approval authority in this regard.
