Teaser	Do you want to permanently export weapons or ammunition from Germany to other countries, permanently import them into Germany or transport them through Germany? Then you need a permit.
Volltext	If you wish to permanently export weapons requiring a permit from Germany to a foreign country, permanently import them into Germany or transport them through Germany, you require a permit. The permit can be applied for by the recipient, the consignor or a carrier (including a commercial forwarding agent). It is also possible for the recipient or shipper to carry out the transportation themselves. The transportation of weapons can also be carried out by a forwarding agent.

Bringing weapons and ammunition to Germany (import)

In order to be allowed to permanently import weapons into Germany, the recipient must have a verifiable permit to acquire and possess the weapons in question (weapons possession card - WBK). If you submit the application as a carrier, you also require a permit to acquire and possess (weapons possession card - WBK) these weapons. If you commission a forwarding agent to transport the weapons, they do not require a weapons possession card (WBK).

If you are importing the weapons from a member state of the European Union (EU), Switzerland, Liechtenstein, Norway or Iceland, you will require an export permit from this state or you must provide credible assurance that you do not require an export permit. If you are importing the weapon from a country outside the European Union (EU) or not from Switzerland, Liechtenstein, Norway or Iceland, you do not require an export license.

Transporting weapons and ammunition through Germany (transit)

In order to be allowed to transport weapons to Germany through Germany, the transporter must have a verifiable permit to acquire and possess (weapons possession card - WBK) the weapons and ammunition in question. If you commission a forwarding agent to transport the weapons, they do not require a weapons possession card (WBK).

If you are transporting the weapons and ammunition from a member state of the European Union (EU), Switzerland, Liechtenstein, Norway or Iceland to another member state of the European Union (EU), Switzerland, Liechtenstein, Norway or Iceland, you will require an export and import permit from that state or you must provide credible assurance that you do not require an export and import permit.

If you are transporting the firearm from a country

outside the European Union (EU) or not from Switzerland, Liechtenstein, Norway or Iceland to another country outside the European Union (EU) or not to Switzerland, Liechtenstein, Norway or Iceland, you do not require an export and import permit. However, you may require other permits, for example under the Foreign Trade and Payments Act (AWG).

If you are transporting the weapons and ammunition from a member state of the European Union (EU), Switzerland, Liechtenstein, Norway or Iceland to a country outside the European Union(EU), Switzerland, Liechtenstein, Norway or Iceland, you require an export license from this country or you provide credible assurance that you do not require an export license.

If you are transporting the weapon from a country outside the European Union (EU) or not from Switzerland, Liechtenstein, Norway or Iceland to a member state of the European Union (EU) or to Switzerland, Liechtenstein, Norway or Iceland, you require an import permit from that country.

Transfer of weapons and ammunition (export) from Germany

In order to export weapons permanently from Germany to a member state of the European Union (EU) or to Switzerland, Liechtenstein, Norway or Iceland, you require an import permit from the state in question or you must provide credible assurance that you do not require an import permit. The transporter requires a permit to acquire and possess the weapons and ammunition in question (weapons possession card - WBK). However, a forwarding agent can also be commissioned with the transportation. This does not require a permit to acquire and possess (weapons possession card - WBK) for the weapons and ammunition in question.

To permanently export weapons from Germany to a country outside the European Union (EU) or outside Switzerland, Liechtenstein, Norway or Iceland, you do not require a weapons permit. Before exporting to

	such countries, it is recommended that you find out for yourself whether you need to comply with other legal provisions, such as the Foreign Trade and Payments Act (AWG) or the laws of that country.

Kosten	The weapons authority charges fees in accordance with No. 1.1 of the Annex to the Thuringian General Administrative Cost Regulations.

### Sachverhalt

• Transfer means taking weapons and ammunition to another country permanently or for retention with the aim of changing possession

• Transfer to Germany: For the transfer of weapons and ammunition from an EU member state, Switzerland, Liechtenstein, Norway or Iceland Weapons license required Export permit from the country of dispatch or credible assurance that none is required The transporter and recipient require permission to acquire and possess the weapons and ammunition to be exported (weapons possession card - WBK) Shipper and transporter or recipient and transporter can be the same person Transportation can be carried out by a commercial transporter who does not need to have a permit to acquire and possess the weapons and ammunition to be exported (weapons possession card - WBK)

• Transit through Germany Transit of weapons and ammunition through Germany from an EU Member State, Switzerland, Liechtenstein, Norway or Iceland to another EU Member State, Switzerland, Liechtenstein, Norway or Iceland Weapons license required Export permit from the country of dispatch or credible assurance that none is required Transporter requires permission to acquire and possess the weapons and ammunition to be exported (weapons possession card - WBK) Transportation can be carried out by a commercial transporter who does not need to have a permit to acquire and possess the weapons and ammunition to be exported (weapons possession card - WBK) Transporter who does not need to have a permit to acquire and possess the weapons and ammunition to be exported (weapons possession card - WBK)

• Transfer (export) from Germany No permit under firearms law for the transfer of weapons and ammunition to a third country, i.e. not to an EU member state, Switzerland, Liechtenstein, Norway or Iceland; other permits may be required, e.g. under the Foreign Trade and Payments Act (AWG) For the transfer of weapons and ammunition to an EU member state, Switzerland, Liechtenstein, Norway or Iceland Weapons license required Import permit from the recipient country or credible assurance that none is required Transporter requires permission to acquire and possess the weapons and ammunition to be exported (weapons possession card - WBK) Shipper and transporter or recipient and transporter can be the
