Teaser	Is your company involved in the commercial transportation of goods or passengers and your company card is not working? Then you can apply for a replacement card from the relevant office.
Volltext	If your company card is inoperable, you will need a replacement immediately. You can apply for a replacement card as an entrepreneur or as an authorized representative. The original card loses its validity when a replacement card is issued. As an entrepreneur, you are responsible for the proper use of the card or cards. You must also ensure that the company card is entered into the tachograph at the beginning and end of the use of the vehicle for your company in order to assign the use of the vehicle to your company.
