Teaser	Is your company involved in the commercial transportation of goods or passengers and your company card has been stolen? Then you can apply for a replacement card from the relevant office.
Volltext	If your company card has been stolen, you will need a replacement immediately. You can apply for a replacement card as an entrepreneur or as an authorized representative.
	The original card loses its validity when a replacement card is issued. If you or other persons find the original card again, you must return it to the issuing office. As an entrepreneur, you are responsible for the proper use of the card or cards. You must also ensure that the company card is entered into the tachograph at the beginning and end of the use of the vehicle for your company. This is the only way that the use of the vehicle can be assigned to your company.
Erforderliche Unterlagen	 Application for replacement of a company card due to theft verifiable documentation of name, address, registered office, legal representative of the company proof of a theft report to the police at the request of the competent authority, the holder may be required to provide an affidavit stating that the company card cannot be returned and for what reasons
Voraussetzungen	 Your company uses vehicles that must have a digital tachograph. Your company card has been stolen.

Verfahrensablauf	 Complete the application, sign it and submit it together with all the necessary documents. The application and documents will be checked for completeness and the card will be ordered from the Federal Motor Transport Authority. The card will be sent to you directly by the Federal Motor Transport Authority. At the same time, you will receive the notification of administrative costs from the TLV. If you want to apply for the company card online: Submit the application and the required documents to the online service (please enter the name) and pay the administrative costs. The application and documents will be checked for completeness and payment and the card will be ordered from the Federal Motor Transport Authority. The card will be sent to you directly by the Federal Motor Transport Authority.

Frist	5 Jahr(e) The company replacement card remains valid until the same date as the stolen original card - if this would have been valid for more than 6 months.
