Expenditure excluded from the grant includes

- Purchase of land and real estate,
- Own work,
- Assets that are financed through leasing, installment plan or supplier loans,
- training, further training, stock and consumables and
- Value-added tax if the company is entitled to deduct input tax.

## Erforderliche Unterlagen

The grant is awarded on application. Applications for a grant must be submitted electronically to the Thüringer Aufbaubank (TAB) via the online portal <https://thueringer-foerderportal.eu> using the forms provided. In addition, the written application must be submitted to the TAB, unless the electronic form replaces the written form. The following documents must be submitted with the application:

- Investment and financing plan
- Confirmation of through-financing/declaration of readiness from the applicant's bank or tax advisor
- De minimis declaration
- SME assessment
- "Explanatory notes on the project" form
- Offers (at least 3 comparable offers for each asset)
- Business registration
- Financing agreements, franchise agreements, if applicable
- for start-ups: Concept showing why the start-up is considered innovative and differs from other companies in the same sector Curriculum vitae of the founding partners Statement from the relevant
