Teaser	Do you want to transfer the permit for your cab business to another entrepreneur? You must submit an application to do this.
Volltext	You need a permit to transfer the authorization to transport passengers commercially by cab. You can submit a corresponding application to the relevant transport authority.
Erforderliche Unterlagen	<p>Two procedural steps must be observed:</p> <ol style="list-style-type: none"> <li>1. The transferor's (former concessionaire's) permit must be valid.</li> <li>2. The person to whom the permit is to be transferred must meet the requirements of Section 13 (1-3) PBefG.</li> </ol> <ul style="list-style-type: none"> <li>• Valid authorization from the previous licensee</li> <li>• Informal justification as to why the cab permit is to be transferred</li> <li>• Declaration by the licensee that they agree to assume the obligations arising from the cab permit</li> <li>• Application for transfer of the cab license including purchase agreement, which shows that the entire company, including the vehicle(s), is also being transferred</li> </ul>

## Sachverhalt

The purchaser of the cab license:

- Application: Surname, first name of the applicant; Place of residence and place of business; for natural persons: Date of birth, place of birth; Number of vehicles, vehicle type, capacity of the vehicles used
- Certificates of employment or certificates of professional competence of the licensee or the person appointed to manage the business of the licensee
- Equity certificate/additional certificate (form in accordance with Section 2(2)(2)/Section 2(3) of the Professional Access Ordinance for Road Passenger Transport PBZugV) of the licensee, not older than 12 months
- Clearance certificate from the tax office, the municipality, the social insurance institution and the employers' liability insurance association for the licensee, not older than 3 months (from the company, the legal representative and the person appointed to manage the business / transport manager of the licensee)
- Certificate of good conduct of the licensee for submission to the authorities in accordance with Section 30 (5) BZRG
- Extract from the central trade register in accordance with Section 150 (5) GewO (for companies) about the licensee
- Extract from the driving aptitude register (FAER) for the licensee

General documents

- Vehicle list, if applicable rental vehicles with rental contract or leasing list
- Proof of liability insurance for cabs including risk index (WKZ)
- Proof of installation of an alarm system or exemption permit in accordance with § 25 BOKraft
- Proof of installation of a fare indicator (taximeter) and, if applicable, the last calibration protocol
- HU protocol according to BOKraft
- Business registration
- In the case of partnerships, the list of partners, the partnership agreement or other proof of contractual

Voraussetzungen	<ul style="list-style-type: none"> <li>• The applicant is already in possession of a cab license as an entrepreneur.</li> <li>• The safety and efficiency of the business are guaranteed.</li> <li>• There are no facts indicating the unreliability of the applicant as an entrepreneur or of the person appointed to manage the business.</li> <li>• The applicant as entrepreneur or the person appointed to manage the business is professionally qualified.</li> <li>• The applicant and the entrepreneurs commissioned by the applicant to provide transportation services must have their registered office or place of business within the meaning of commercial law in Germany.</li> </ul> <p>Legal entities under public law are deemed to meet the requirements.</p>
Kosten	<p>Gebühr: 50€ - 1.000€</p> <p>in accordance with Annex 1, point III, item 3, to § 1 of the Costs Ordinance for official acts in the paid or commercial transportation of passengers by motor vehicle</p>
Verfahrensablauf	<p>Proceed as follows to obtain a transfer of the permit for the commercial transportation of passengers by cab:</p> <ul style="list-style-type: none"> <li>• Submit a corresponding application to the transport authority responsible for you and enclose all the necessary documents with the application.</li> <li>• The authority will process both applications (old licensee and new licensee) promptly and carry out the necessary hearing procedures.</li> <li>• You will receive a decision on the transfer of the cab license.</li> <li>• The new licensee will also receive a decision on the approval of the transfer of the cab license and a further decision on the granting of the cab license</li> </ul>
Bearbeitungsdauer	<p>The processing time may vary between the competent transport authorities. The processing time may depend, among other things, on whether all</p>

	documents relevant to the decision have been submitted or whether additional requests for documents are necessary.
Frist	Deadlines only start to run when an application is ready for a decision. If your application is complete, a decision will be made within 3 months. The deadline can be extended by 3 months if necessary.
