Volltext	In order to operate a continuing education center for continuing education in the healthcare and social professions regulated in Thuringia, you must submit an application for recognition of the continuing education center to the Thuringian State Office of Administration. Recognition is based on the Thuringian law on further training in the specialist healthcare and social professions and the associated Thuringian ordinance on the implementation of further training in the specialist nursing professions.
