Volltext	If you are admitted to or move into a hospital, nursing home or other facility that serves the care of people in need of care or disabled people or home education, you are not subject to the registration obligation as long as you are registered for another residence in Germany. If this is not the case, you must register with the registration authority as soon as your stay exceeds three months. If you are unable to register in person, this must be done by the managers of the facilities.
