The single points of contact also handle the entire electronic processing of administrative procedures for you. They receive your application and forward it to the relevant authorities. This saves you visits to the authorities. The network of single points of contact consists of internet portals and personal contacts.

Please note If you want to do business or work in another European Union (EU) country, you can find the right single point of contact on the EU Commission's website.

If you want to set up a business or work as a freelancer in Rhineland-Palatinate or if you want to work temporarily as a business or freelancer across national borders in Rhineland-Palatinate, you have the option of contacting the Single Point of Contact (EAP).

Erforderliche Unterlagen

Which documents you need to submit depends on your specific project.

Voraussetzungen

The single point of contact service can be used by

- Service providers,
- companies,
- founders and
- persons who wish to have their professional qualifications recognized

from

- the Federal Republic of Germany
- a member state of the European Union (EU) or
- a member state of the European Economic Area (EEA), currently Iceland, Liechtenstein or Norway.

Kosten

The information services provided by the points of single contact are generally free of charge. In some federal states, you have to pay fees for advice and the handling of administrative procedures via a single

point of contact.

If you want to use the single point of contact service, you must contact the single point of contact in the federal state in which you want to carry out your project:

- Go to the website of the single point of contact for the federal state relevant to you.
