Volltext	<p>The Wohnberechtigungsschein is an official certificate that a tenant can use to prove that he or she is entitled to move into a publicly subsidized apartment (social housing) in Rhineland-Palatinate.</p> <p>The certificate of eligibility is valid for a maximum of one year.</p> <p>You can apply for the housing entitlement certificate from the responsible office in two different ways:</p> <ul style="list-style-type: none"> <li>• General certificate of eligibility for housing The applicant is entitled to move into any social housing.</li> <li>• Special housing entitlement certificate Prospective tenants apply for a specific social housing unit in compliance with the special eligibility requirements. With this certificate of eligibility for housing, the applicant is entitled to move into (only) this specific social housing.</li> </ul>
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• identity card</li> <li>• Proof of income from all persons wishing to move into the apartment (e.g. proof of income to be completed by the employer, last income tax assessment/declaration and last tax-recognized profit or proof of tax assessment for tradespeople/self-employed persons).</li> </ul>

Voraussetzungen	<p>Households whose qualifying income does not exceed the relevant income limit receive a housing entitlement certificate. The income limit depends on the number of people in the household and the relevant subsidy programs. A housing entitlement certificate is issued if the total income of the household does not exceed the income limit according to § 13 LWoFG. See also "Calculating entitlement to a housing entitlement certificate".</p> <p>The total annual income is made up of the gross annual income of all persons belonging to the household. It is calculated in accordance with the State Housing Assistance Act.</p> <p>In exceptional cases, a housing entitlement certificate can also be issued without complying with the relevant income limits to take into account the special needs of a member of the household or to avoid particular hardship. This must be examined according to the circumstances of the individual case.</p>
Kosten	There are no fees or costs.
Verfahrensablauf	You can submit the application to the responsible office in person or in writing. The person seeking accommodation must submit a declaration of income for themselves and each person in their household.
Bearbeitungsdauer	
Frist	The certificate of eligibility for housing must be presented to the landlord or landlady before moving into a subsidized apartment.
