Volltext	In a restricted invitation to tender (national), the contracting authority (awarding body) invites certain companies to submit a tender. This also applies to the restricted procedure (EU-wide). This must be carried out if the order volume exceeds the threshold value.  Competition is restricted in both cases, as the company must already be known to the awarding authority.  Note: If the anticipated contract value of the planned restricted tender exceeds EUR 25,000 excluding VAT, contracting authorities must inform the companies in advance. This advance information is published in the special tender media.
	The contracting authority can carry out a public competition in advance. In restricted procedures and in certain cases also in restricted invitations to tender, the call for competition is mandatory. To this end, the awarding authority publishes the planned contract award in special tender media. All interested companies can submit requests to participate. The awarding authority selects the suitable companies in accordance with the general principles for awarding contracts. It invites them to submit a bid.  Note: State tenders are published on the procurement marketplace; EU tenders must always be published in

	the EU Official Journal.
	Contract advisory offices can help the contracting authority to select the companies to be invited to tender.
	The tender documents will tell you what deadlines you have to meet for submitting requests to participate and tenders.
Erforderliche Unterlagen	The tender documents will tell you which documents, samples or specimens you must enclose with your request to participate and tender.
Voraussetzungen	A restricted invitation to tender or a restricted procedure is only possible under certain conditions, for example in the following cases:
	<ul> <li>For construction services, certain value limits are not exceeded (national).</li> <li>Due to special requirements, only a certain group of contractors can provide the service.</li> <li>A public invitation to tender would cause disproportionately high costs for the contracting authority or the applicant companies.</li> <li>A public invitation to tender that has already been carried out has not led to an acceptable or economical result.</li> <li>A public invitation to tender is inappropriate for reasons of urgency or confidentiality, for example.</li> </ul>
Kosten	Costs incurred by you for processing the offer will not be reimbursed.  Exception: The client requires the preparation of drafts, plans, drawings, calculations or other documents. In this case, the client must reimburse reasonable costs to all applicants.
Verfahrensablauf	Find out about competitions in the tender media. If you would like to take part, submit an application for participation in the competition to the awarding authority.
	The awarding authority will evaluate the applications. If the awarding authority has selected you, it will ask you

to submit a tender. It will send you the tender documents.

You must sign the processed tender documents and send them to the awarding authority. The tender documents will tell you whether you can or must submit the documents electronically.

Apart from a few exceptions, you will be awarded the contract in writing. The award of the contract is also deemed to be the conclusion of the contract.

Find out about participation competitions in the tender media. If you would like to take part, submit an application for participation in the competition to the awarding authority.

The awarding authority will evaluate the applications. If the awarding authority has selected you, it will ask you to submit a tender. It will send you the tender documents.

When preparing your tender, you must observe various formal and content-related requirements, for example

- the legally binding signature of the tender,
- the deadline for submission must be met,
- the complete entry of the requested prices.
- the complete declarations and evidence required by the client.

Attention: You may not change the contract documents!

You must sign and return the processed tender documents to the awarding authority. The tender documents will tell you whether you can or must submit the documents electronically. If this is the case, you must provide them with an electronic signature and transmit the data in encrypted form.

The awarding authority opens the tenders after the tender deadline has expired. It will examine tenders that have been received correctly and on time
