Teaser	If anything changes with regard to your identity card or the data entered on it, you must report this immediately.
Volltext	The data in the identity card must always be up to date, otherwise it becomes invalid. In addition, as a German citizen you are obliged to have an identity card from the age of 16. You are therefore obliged to notify the Bürgeramt of the following: • Name changes • if you have lost your identity card • if your identity card has been stolen • if you have recovered your identity card after reporting it as lost • Note: You can also report the loss and theft of your identity card to the police. There are 2 exceptions: • If your address or height changes, your ID card will still be valid. • If you do not comply with the obligation to report a change of address within Germany, you are acting irregularly.
Erforderliche Unterlagen	in the event of a change of data, for example a change of name: • Proof of the new name by means of a new civil status

	certificate (for example, marriage certificate, register extract from the registry office concerning the new name). • Biometric photograph
Voraussetzungen	You are in possession of a German identity card.
Kosten	You will not incur any costs as a result of the notification. If you report a change of name, fees may be incurred as the document must be reissued if there is no valid passport with the new name.
Verfahrensablauf	Report the change, loss, theft or subsequent recovery to a Citizens Advice Bureau. You can also report loss and theft to the police.
Bearbeitungsdauer	Your message will be recorded immediately.
Frist	You must make the notification without delay.
