Teaser	If you wish to extend the inspection period for an installation requiring monitoring, you must apply to the competent authority.
Volltext	You can apply for an extension of inspection periods for installations requiring monitoring for the following installations: • Elevator systems • Installations in potentially explosive atmospheres • Pressure systems including steam boiler systems • Cranes • Liquefied petroleum gas systems • Mechanical tools for event technology

Erforderliche Unterlagen	• Information on the system, the place of use and operating times (design, type of production, quality, operational influences) • Result of the risk assessment for the plant • Test certificates for the most recent tests carried out • Information on the measures to be taken to ensure safety • Expert opinion on the equivalence of the measures • Information on maintenance by a specialist fitter or company
Voraussetzungen	They shall establish an equivalent level of security by means of technical and/or organisational measures.

Verfahrensablauf	You may request the extension of the review period in writing to the competent authority. • Submit the application and the required documents. • The authority will examine your application and the documents submitted. • You will receive a notification of the extension of the review period or a rejection of the review period extension.
Bearbeitungsdauer	4 Woche(n) as a rule;
Frist	As a rule, at the earliest after the first periodic inspection. If there is sufficient knowledge about the operational influences on the service life, the extension of the inspection period can also be approved before the first periodic inspection. However, no later than 8 weeks before the expiry of the statutory review period.
