Teaser	You can have your residence permit for employment extended before it expires, regardless of your qualification as a skilled worker, if you wish to continue your employment in Germany.
Volltext	The residence permit for employment regardless of the qualification as a skilled worker is a temporary residence permit. You can apply to extend your residence permit if you wish to continue your employment beyond the period of validity of your residence permit.
	Apply for an extension of your residence permit at least eight weeks before the expiry date at the immigration authority responsible for your place of residence.
	The same conditions apply for the extension of the residence permit as for the issue. In particular, you should be able to present an employment contract or a concrete job offer.

	If you were obliged to attend an integration course when your residence permit was first issued, this will be taken into account when your residence permit is extended. If you have not yet taken part in an integration course, the immigration authority may reject your application to extend your residence permit. If you have not yet completed the integration course, your residence permit will generally only be extended for one year at a time until you successfully complete the course or provide proof that you have been integrated into society and social life in another way. If your residence permit is extended, it will be limited in time again. The residence permit will be extended for the duration of the employment contract. The residence permit cannot be extended if this was already ruled out when it was issued or when it was last extended.

Sachverhalt

You have a recognized and valid passport or passport substitute as well as a valid residence permit for employment regardless of your qualification as a skilled worker in accordance with Section 19c (1) of the Residence Act in conjunction with the Employment Ordinance.

	<ul> <li>expire in the near future.</li> <li>There is no interest in deporting you.</li> <li>Your stay does not jeopardize or impair the interests of the Federal Republic of Germany.</li> <li>You can secure your livelihood and health insurance cover from your income without claiming public benefits.</li> <li>You have a concrete job offer or an employment contract with the same or another employer.</li> <li>The Federal Employment Agency has agreed to your taking up employment (approval is usually obtained from the Foreigners' Registration Office if this is required).</li> </ul>
Kosten	<ul> <li>Extension of the residence permit for employment regardless of the qualification as a skilled worker: - for a further stay of up to three months: EUR 96 - for a further stay of more than three months: EUR 93</li> <li>Under certain conditions, a fee reduction or fee exemption may be possible. Note: The residence permit in the form of the electronic residence permit must be reissued for the extension. The fee for reissuing the card body is EUR 67.00.</li> </ul>
Verfahrensablauf	<ul> <li>The extension of your residence permit must be applied for at the foreigners authority responsible for your place of residence.</li> <li>Depending on the foreigners authority and your request, it may be possible to apply online. Find out whether your foreigners authority offers electronic application for a residence permit.</li> <li>If the application can only be made in person, arrange an appointment with the immigration office.</li> <li>During the appointment, your application will be accepted and your supporting documents checked (please bring these with you to the appointment). Your fingerprints will be taken for the issue of the electronic residence permit (eAT).</li> <li>In the case of an electronic application, the Foreigners' Registration Office will contact you after receiving your online application to arrange an appointment for an interview at the Foreigners'</li> </ul>

	<ul> <li>Registration Office. During the appointment, your documents will be checked (please bring them with you to the appointment) and your fingerprints will be taken for the eAT card to be issued.</li> <li>If your application is approved, the Foreigners' Registration Office will arrange for the eAT card to be issued.</li> <li>After about six to eight weeks, you can collect your eAT card from the Foreigners' Registration Office.</li> <li>Fees are charged for the extension of the residence permit. The time and form of payment vary depending on the authority.</li> </ul>

Frist	<ul> <li>Extension of the residence permit: no later than eight weeks before your valid residence permit expires</li> <li>Objection period: 1 month</li> </ul>

Kurztext	<ul> <li>Residence permit for the purpose of gainful employment Extension for the purpose of employment regardless of qualification as a skilled worker</li> <li>A residence permit for the purpose of employment irrespective of the qualification as a skilled worker can be extended if it is due to expire in the near future and the employment is to be continued.</li> <li>The extension must be applied for at least eight weeks before the expiry date.</li> <li>An extension of the residence permit for the purpose of employment, regardless of the qualification as a skilled worker, is only possible if the requirements that were met when the permit was first issued are still met.</li> </ul>

	<ul> <li>In the course of the extension, the residence permit is again limited in time.</li> <li>If the period of validity of the approval obtained when the residence permit was issued has expired, the approval of the Federal Employment Agency must be obtained again.</li> <li>If the obligation to attend an integration course was stated when the residence permit was issued, proof must be provided that this obligation has been fulfilled. If the integration course has not yet been completed, the foreigners authority can refuse to extend the residence permit or only extend it for one year until the course has been successfully completed or proof has been provided that integration into social life has taken place in another way.</li> <li>An extension is excluded if this was already ruled out by the immigration authority when the permit was issued or when it was last extended.</li> <li>Depending on the foreigners authority and your request, you can apply online or in person.</li> <li>Fees are charged for the extension. The time and form of payment vary depending on the authority</li> <li>Responsible: the foreigners authority responsible for the applicant's place of residence</li> </ul>
